

I bring you a story of an innocent man from St. Louis, MO who is fighting for his life against a widespread corrupt state power of Tennessee, and I beg you to investigate, verify my claims, and share with a public that deserves better than a government who so freely breaks law.

The Davidson County courts in Nashville are rife with in-house problems with corruption. Casey Moreland is not the only judge who deserves to be in prison right now. DA Glenn Funk entered office with a promise to clean up the mess that his predecessors left, but a Nashville case from 2011 has proven to *Making a Murderer* lawyer Kathleen Zellner that a spotlight must be shown on the court of Davidson County Judge Monte Watkins and the entire DA office of Glenn Funk to root out the absurd unconstitutional railroading of an actually innocent man, Timothy Guilfooy, and achieve actual justice.

This is not the first time that I have tried to get media to look at Tim's story, but I hope our recent developments may encourage you to look into this cesspool of a case. First, I have proof of everything I will say here and trial and appeal media in the form of public records and other solid documentation. The only piece of evidence I do not have access to is the video that 1. was never shown in the public courtroom during trials, 2. was shown to the jury by the bailiff off the record after the closing arguments, 3. was edited solely by the prosecution and never shown to Tim, and 4. that multiple jurors claim was the sole reason they convicted Tim.

Kathleen Zellner has jumped at Tim's case because the proof shown IN court was nowhere near sufficient to convict Tim of the seven counts of child sexual abuse that he is now serving 40 years for in Northwest Correctional Complex in Tiptonville, TN. Tim had alibis and was able to show that the prosecution was actively suborning their witness' perjury. Two trials were held, and the second trial would also have been a hung jury, possibly an acquittal, if not for the extraneous illegal mystery video shown with full knowledge and assistance of Watkins' court.

It's also probably no surprise to you that all of Tim's state appeals have been denied. We have recently found, with an investigation by the TN Board of Professional Responsibility, that his appellate lawyer James O. Martin of Nashville, changed the legal theory of his final brief for Tim against Tim's orders after Glenn Funk offered him a top position in the DA's office, which Martin accepted. The omission of one issue which Martin agreed in writing with Tim to include was the explicit reason the TN Court of Criminal Appeals denied that appeal. Martin's job offer was not disclosed to Tim while he was writing this argument, and he did not tell Tim he was changing his theory of the case before he turned in a brief that was a sure-fire loser. This issue Tim instructed Martin to include was to appeal Judge Watkins' stonewalling of legal juror testimony about being exposed to the video that was off the record in violation of TN Rule of Evidence 606b. Martin "changed his mind" of his own volition that it wasn't worth mentioning that Watkins had wrongly disallowed Tim's witness, Jury foreperson Hilary Hoffman, to take the stand and under oath, report the breach of Tim's Constitutional trial rights.

This is but the beginning of the knee-deep violations of law that TN District and State powers have chosen to engage in to prevent Tim's treatment from coming to light. A third trial, should

we ever get one, will show with evidence we've gathered over the past seven years he has been incarcerated, that Tennessee threw their law-violating weight behind the wrong case.

The following links will lead you to most of the information that supports these claims. Although I may be considered biased because Tim is my brother, the truth is the truth and these facts will be borne out upon scrutiny, for which I humbly beg. This has destroyed Tim's life and our family, and will shake all citizens of Tennessee and indeed the country to their core. We live in a nation of laws and I think the people deserve the disinfectant of sunshine on their sullied courts.

Please look into Tim's case as soon as you can. He is currently being harassed in the form of solitary confinement and denial of federal and human rights by the TDOC and faceless Nashville powers that fear exposure of their wrongdoing. There is an attempt to frame him for baseless charges of criminal conduct and they are not letting him speak to us or his lawyers freely. We need your help and attention.
